The Rental Management Process

1. View Rental Property & Obtain Property Information

- The Rental Manager will arrange a meeting to view the rental property and will obtain the required information, such as number of bedrooms, number of bathrooms, square footage, quality and condition of property, and may suggest items that could increase the marketability of your investment property.
- The Rental Manager may take pictures of the rental property during the first visit, or may wait until certain items are completed.

2. Complete Rental Property Management Agreement

• Together we will determine your needs and expectations and review and complete a Rental Property Management Agreement and other required documents (ID form, Designated Agency form).

3. Advertise & Show Rental Property

- The Rental Manager will begin advertising and marketing your property by creating a professional website for your property on Century21.ca, placing ads on local online classified websites, and other sources of media.
- The Rental Manager will arrange showings of your rental property with prospective tenants and promptly respond to any inquiries.

4. Tenant Selection & Tenancy Agreement

- The Rental Manager will evaluate prospective tenants on your behalf by conducting credit and reference checks.
- The Rental Manager will complete a Tenancy Agreement on your behalf with the tenant (a minimum term of 1 year is suggested).
- The Rental Manager will conduct a move-in and move-out inspection and abide by the requirements set under the Residential Tenancy Act of BC.

5. Rental Income & Expenses

- The Rental Manager will collect the monthly rent on your behalf and have it deposited into your provided bank account (mid-month), less the monthly management fee and any expenses.
- We will provide you with monthly account statements, a list of income and disbursements, and an annual summary to assist with filing of your income tax.
